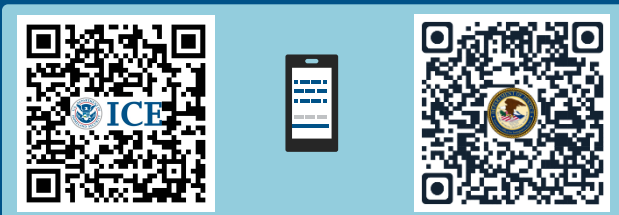
UPDATE YOUR ADDRESS SO YOU DON'T MISS YOUR APPOINTMENTS OR COURT DATE

To ensure the best outcome for your case, you have to keep your address current with ICE and the Immigration Court. You should notify within 5 days of your move but if you didn't, you still can.

You can also change your address online at:

Remember, you are required to:

- Know where your local ICE office is located
- Go to all scheduled appointments with your Deportation Officer and go to all Immigration Court hearings
- Keep all immigration paperwork
- Provide your correct or new address to the local ICE Office
- Provide your correct or new address to the Immigration Court

A Change of Address form

To change your address with the Immigration Court by mail, you must file Form EOIR-33, available at the local Immigration Court and online at <https://www.justice.gov/eoir/form-eoir-33-eoir-immigration-court-listing> You must do this within 5 days of moving to a new address.

What do I do?

1. Complete the Change of Address form (Form EOIR-33) and make three additional copies.

* 2. Mail the original Change of Address form to the Immigration Court. (This can also be completed online at <https://www.justice.gov/eoir/form-eoir-33-eoir-immigration-court-listing>)

* 3. Mail a copy of your completed Change of Address/Contact Information Form (EOIR 33) to the DHS ICE Office of the Principal Legal Advisor (OPLA) that is closest to the court. Addresses for DHS ICE OPLA Field Locations where copies can be mailed or delivered in-person are available online at <https://www.ice.gov/contact/legal>.

4. Provide one copy of the Change of Address Form to your ICE Officer at check-in.

5. Keep one copy of the Change of Address form in a safe place for your records.

6. You will need to complete a Change of Address form for each member of your family who is in Immigration Court proceedings.

* You should send the documents via certified mail so you have proof that you sent them. This means that you request a receipt be returned to you as proof that you sent the documents. You can send certified mail from any post office.

Alien's Change of Address Form/ Immigration Court
If you move or change your phone number, the law requires you to file this Change of Address Form with the Immigration Court. You must file this information and record will remain unchanged.
Failure to appear at any hearing before an Immigration Judge, when notice of that hearing or other official correspondence was served on you or sent to the address you provided, may result in one or more of the following actions:
You are in removal proceedings:
Your hearing may be held in your absence under Section 240 of the Immigration and Nationality Act (INA), and an order of removal may be entered against you. Furthermore, you may become ineligible for the following forms of relief from removal for a period of 10 years after the date of the entry of the final order:
1. Voluntary Departure as provided for in Section 240B of the INA;
2. Cancellation of Removal as provided for in Section 240A of the INA;
3. Adjustment of Status or Change of Status as provided for in Sections 245, 248, or 249 of the INA.
You are in deportation proceedings:
Your hearing may be held in your absence under Section 242D of the Immigration and Nationality Act (INA) (1995) and an order of deportation may be entered against you. Furthermore, you may become ineligible for the following forms of relief from deportation for a period of 5 years after the date of the entry of the final order:
1. Voluntary Departure as provided for in Section 242D of the INA (1995);
2. Suspension of Deportation or Voluntary Departure as provided for in Section 244 of the INA (1995);
3. Adjustment of Status or Change of Status as provided for in Sections 245, 248, or 249 of the INA (1995).
You are in exclusion proceedings:
Your application for admission to the United States may be considered withdrawn, and your hearing may be held in your absence and an order of exclusion and deportation entered against you.
